Recently you have submitted an application for a new pitch on Buikslotermeerplein.

Unfortunately, the district has reacted negatively to your QuickScan.

We presented them with your QuickScan and they could indicate which of the two options applied to your application. They have chosen answer A:

A. "Based of the information that has been presented, it is impossible to get a pitch." (We advise the entrepreneur not to submit an official application)

Buikslotermeerplein is only available for the market not for a pitch. If you want to stand on the market, you have to come to the Market counter at City Hall. Opening hours of the Market counter are Monday, Tuesday, Wednesday, Friday: 10-13, and Thursday: 13-16.

Then you can get registered in the Register Ambulante Handel. The cost of a registration is €48. You can pick 7 markets of Amsterdam including Buikslotermeer.

Unfortunately, we have no better news for you concerning this application. We would like to hear from you within two weeks what your decision is.

If we have not received a response in two weeks, we will assume that you are refraining from submitting an official application.
