In the attachment you will find an extensive 'account of facts' as it has been produced by our Mayor, the Police Chief and the Chief Prosecutor and as such presented to our city council on November 11th, ahead of the debate in the city council on these events which took place yesterday.

This account presents the information currently available.

We have shared this account as well with the President of the European Parliament and the Chairs of the Political Groups.

A broader and independent investigation on the events will be commissioned, in agreement with the city council, and should be available at a later stage for further discussion and reflection within the city council.

At this point we are not informed as to whom from the European Commission would be present at this debate and hence we hope with this to have informed you for now sufficiently on the recent violence in our city.

Should there be a wish from the Vice-President or the Commissioner to have a word with our Mayor, ahead of the debate in the EP, we might try to arrange for this. However, as currently the issue is debated also in our national Parliament, the agenda of the Mayor will be quite restrained.
