Do you get answer B? Then you can choose to submit an official application. Then you have to pay a fee of € 231, -. You must also pay this fee if you do not receive a permit in the end.
You must therefore decide yourself whether you want to make an official application. You decide this after you receive the answer to the QuickScan. You can count on this to take a few weeks.

You can apply for a permit for a stand that doesn't exist yet. This means that you will be the one who is going to take the initiative to create a stand. The only districts to apply for a permit for a pitch are in Noord, West, Nieuw-West and Zuidoost. The other districts Centrum, Zuid and Oost are not open to granting any applications.

Sometimes the districts write out pilots for foodtrucks or temporary "staanplaatsen". Usually you can find information about this on the website www.amsterdam.nl/markt, **but not always**.

If you want to apply for a permit for a pitch in the **Noord, West, Nieuw-West and Zuidoost** district, you can submit a QuickScan.

would be possible for you to provide these information/indicate me where I can find them.


