THE LAWFARE PROJECT TO HOST PRESS CONFERENCE ANNOUNCING REPRESENTATION OF VICTIMS FOLLOWING RECENT ANTISEMITIC ATTACKS

Director of Litigation of Leading International Jewish Civil Rights Organization to Address the Strategic Support Being Offered to Victims Assaulted Following Soccer Game

AMSTERDAM – Tuesday, December 10, 2024 – [The Lawfare Project](#) will host a press conference outside **Rechtbank Amsterdam, Parnassusweg 280, 1076 AV Amsterdam at 11 a.m. CET on Wednesday, December 11 (tomorrow)**. Ziporah Reich, Director of Litigation at The Lawfare Project and local counsel will address how they will work to enforce the rights of victims of the recent antisemitic attacks that took place following an Israeli soccer game last month in Amsterdam.

Supporters of Maccabi Tel Aviv were assaulted in various parts of the city on November 7, following the soccer team's loss to local team Ajax. The scope of The Lawfare Project's representation will be to work with local counsel, Peter Plasman of Kötter L'Homme Plasman Lawyers, to combat antisemitism and provide public advocacy for the victims.
