It was subsequently enriched by Sicilian people with the addition of the characteristic “panatura”, a golden crispy shell of seasoned bread crumbs. It makes the composition tastier and allows the Arancino to be easily consumed everywhere.</p> <p>The Sicilian <b>Cannolo</b> one of the most famous Sicilian sweets. The myth places its birth in a monastery in Caltanissetta during the Arab colonisation of the IX-XI century. It is made of a crispy peel and stuffed with sugared ricotta cheese.</p>
